Eye Contact	<p>If this product comes in contact with the eyes:</p> <ul style="list-style-type: none">▶ Immediately hold eyelids apart and flush the eye continuously with running water.▶ Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids.▶ Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes.▶ If irritation persists get medical advice / attention.▶ Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.
Skin Contact	<p>If skin or hair contact occurs:</p> <ul style="list-style-type: none">▶ Immediately flush body and clothes with large amounts of water, using safety shower if necessary.▶ Quickly remove all contaminated clothing, including footwear.▶ Wash skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre.▶ If irritation persists get medical advice / attention.
Inhalation	<ul style="list-style-type: none">▶ Inhalation of spray or mist may cause respiratory irritation. If this occurs remove victim to fresh air.▶ If symptoms persist seek medical advice / attention.
Ingestion	<ul style="list-style-type: none">▶ Immediately give a glass of water.▶ First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Information on toxicological effects

Inhaled	The material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage. The material has NOT been classified by EC Directives or other classification systems as 'harmful by inhalation'. This is because of the lack of corroborating animal or human evidence.
Ingestion	The material can produce chemical burns within the oral cavity and gastrointestinal tract following ingestion.

Chronic	Long-term exposure to respiratory irritants may result in disease of the airways involving difficult breathing and related systemic problems. Skin contact with the material is more likely to cause a sensitisation reaction in some persons compared to the general population.
